Due to recession in the past in the real estate sector owing to slowdown in demand, the company faced lack of adequate sources of finance to fund execution and completion of its ongoing projects resulting in delayed realisation from its customers. The company is facing tight liquidity situation as a result of which there have been delays/default in payment to lenders, statutory liabilities, salaries to employees and other dues. However, considering substantial improvement in real estate sector recently, the Management is of the opinion that all such issues will be resolved in due course by required finance through alternate sources, including sale of non-core assets.

पुणे, दि. १२ (वार्ताहर) : ऑनलाईन शॉपिंग साईटच्या माध्यमातून घरगुती सामानाची डिलिहरी करण्यासाठी जात असलेल्या तरुणाचा मधुंधर चालकाने चालविलेल्या भरधाव कारच्या धडकेत मृत्यू झाल्याची घटना वडगाव बुद्रुक येथील सिंगड कॉलेज रोडवरील क्रिकेट मैदानाजवळ घडली. धडक दिल्यानंतर कारचालकाने जखमीला मदत न करता घटनास्थळावरून पळ काढल्याने संताप व्यक्त केला जात आहे.
